# APPLICATION FOR RECOGNITION ORDERS PURSUANT TO THE MARINE AND COASTAL AREA (TAKUTAI MOANA) ACT 2011

#### This document notifies you that:

- 1. The Applicant applies to the High Court for orders pursuant to s 98 of the Marine and Coastal Area (Takutai Moana) Act 2011 (**Act**) recognising that Ngāti He holds:
  - 1.1 Customary Marine Title pursuant to s 58 of the Act including recognition of waahi tapu pursuant to s 78 of the Act; and
  - 1.2 Protected Customary Rights pursuant to s 51 of the Act.

#### **Applicant**

- 2. The Applicant is the Chairperson of the Ngati He Hapu Trust established by trust deed dated 23 October 2013 to represent Ngāti He (**Trust**). The Trust was mandated to represent Ngāti He by hapu members at a Ngati He hui a hapu.
- 3. The Trust is recognised by the Ngai Te Rangi Settlement Trust as the representative of Ngāti He and an appropriate entity to receive Treaty of Waitangi settlement assets and distributions.

### Ngāti He

- 4. Ngāti He is a hapu of Ngai Te Rangi.
- 5. The founding ancestor of the hapu is Turāpaki.
- 6. Ngati He source their mana, tino rangatiratanga and kaitiakitanga from:
  - 6.1 the Ngai Te Rangi conquest of Tauranga Moana; and
  - 6.2 the acquisition of rights through ahi kaa and whanaungatanga.
- 7. Ngati He has continuously exercised mana, tino rangatiratanga and kaitiakitanga in their rohe since the seventeenth century to the present day.
- 8. Ngati He retains ownership of blocks of Maori freehold land adjacent to or including the common marine and coastal area. Such blocks include:
  - 8.1 Maungatapu No.2;

- 8.2 Maungatapu No 1P;
- 8.3 Lot 1 DP South Auckland 14986 Maungatapu marae Maori reservation;
- 8.4 Maungatapu No 3;
- 8.5 Waitaia 2A:
- 8.6 Te Ahipoutu;
- 8.7 Te Ngaio No 1;
- 8.8 Lot 2 DP South Auckland 18945;
- 8.9 Section 1 SO Plan 59391 and Part Ranginui No 4 block;
- 8.10 Ranginui 12;
- 8.11 Ranginui No 1B; and
- 8.12 Ranginui 2B.

#### **Application Area**

- 9. The area to which this application relates is the common marine and coastal area (as defined in s 9 of the Act) in the following area:
  - 9.1 Around the Maungatapau peninsular;
  - 9.2 in and around the Waimapu estuary;
  - 9.3 along the Te Papa peninsular through Te Awanui and to Mauao and out to the coast;
  - 9.4 in and around Te Tahuna o Rangataua (Rangataua Harbour) including the souther side of the Matapihi peninsular; and
  - 9.5 along the coast from Mauao to Te Tumu and out to sea.

#### **Recognition order for Customary Marine Title**

- 10. The Applicant repeats paragraphs 4-8 and seeks a recognition order for Customary Marine Title for the Application Area on the grounds that the Application Area:
  - 10.1 is held in accordance with the tikanga of Ngati He; and
  - 10.2 has been exclusively used and occupied by Ngati He from 1840 to the present day without substantial interruption.
- 11. The order for customary marine title should be in the name of the trustees of the Ngati He Hapu Trust as representatives of Ngati He.

#### **Recognition order for Protected Customary Rights**

12. The Applicant repeats paragraphs 4-8 and seeks a recognition order for the following Protected Customary Rights in the Application Area:

- 12.1 exercise of kaitiakitanga over the moana, awa, islands, islets, rocks and waters of Ngati He;
- 12.2 exercise of kaitiakitanga over waahi tapu, sites of significance, customary resource gathering areas and generally within the common marine and coastal area;
- 12.3 collecting customary resources from the common marine and coastal area;
- 12.4 seeding or gathering fish and seafood;
- 12.5 the mooring, launching and landing of waka;
- 12.6 planting, cultivating or gathering plants and aquatic flora;
- 12.7 extracting minerals;
- 12.8 collecting stone, wood and other natural resources; and
- 12.9 nohoanga.
- 13. The Applicant seeks a recognition order on the following grounds:
  - 13.1 Ngati He has exercised the Protected Customary Rights in the Application Area since 1840;
  - 13.2 Ngati He continues to exercise the Protected Customary Rights in accordance with tikanga in the Application Area; and
  - 13.3 the Protected Customary Rights have not been extinguished by law.
- 14. The recognition order for the Protected Customary Rights should be in the name of the trustees of the Ngati He Hapu Trust as representatives of Ngati He.

  - 15.1 the affidavit of Mita Michael Ririnui sworn on 3 April 2017; and
  - 15.2 Re Tipene [2016] NZHC 3199.
