This document notifies you that —

- 1. The Applicant Roger Tu Lewis Tichborne ("Roger Tichborne or "the Applicant") will, on 3 April 2017, apply to the Court for a recognition order under s 98 of the Marine and Coastal Area (Takutai Moana) Act 2011 ("the Act").
- 2. The Applicant will seek a recognition order for Customary Marine Title ("CMT") under the requirements of s 58 of the Act.
- 3. The Applicant will seek to include recognition of wāhi tapu and wāhi tapu areas in a CMT order under s 78 of the Act.
- 4. The Applicant will seek a recognition order for Protected Customary Rights under the requirements of section 51(1) of the Act.

The Applicant Group

- 5. The Applicant Group is Nga Hapū o Tokomaru Akau ("NHOTA").
- 6. NHOTA is comprised of two neighbouring hapū Te Whānau a Te Aotawarirangi ("Te Ao") and Te Whānau a Ruataupare ("Ruataupare").
- 7. Te Ao and Ruataupare are located in Tokomaru Bay on the East Coast of the North Island of New Zealand.
- 8. They are widely recognised as the only holders of mana whenua and mana moana over the Tokomaru Bay area.

Representative of Applicant Group

- 9. NHOTA prefers, at this stage, not to name an individual person or entity to be the holder of any order that may be awarded.
- 10. NHOTA's preference is to establish a Trust entity to hold any order awarded by way of this application.

Specified Area to which Application Relates

- 12. The common marine and coastal area to which this application relates is in and around Tokomaru Bay from Ngutu O Ngore (Orange Bay) in the north, to Mawhai Point in the south, and extending out 12 nautical miles from each point along the coastline ("the specified area").
- A map of the specified area is attached to the attached affidavit of Margrette Ryland-Daigle.

Grounds for CMT Application

- 14. NHOTA holds the specified area in accordance with tikanga.
- 15. NHOTA, has exclusively used and occupied the specified area from 1840 until the present day.
- 16. Title to the specified area has not been extinguished as a matter of law.
- 17. NHOTA has lands abutting the specified area and have held these lands since 1840 until the present day.

18. NHOTA has practiced non-commercial customary fishing rights in the specified area since 1840 until the present day.

Recognition of Wāhi Tapu

- 19. Various wāhi tapu and wāhi tapu areas, of importance to Te Ao and Ruataupare, are located within the specified area.
- 20. If this application for a CMT recognition order is successful, NHOTA will seek to include recognition of these wāhi tapu as part of the order under s 78 of the Act.
- 21. The grounds upon which recognition of wāhi tapu are sought include:
 - a. The connection that the hapū of NHOTA has with the various wāhi tapu and wāhi tapu areas; and
 - b. That NHOTA requires prohibitions and/or restrictions on access to protect these wāhi tapu and wāhi tapu areas.
- 22. As the wāhi tapu within the specified area are extensive, the relevant wāhi tapu and wāhi tapu areas are outlined and explained in the attached affidavit of Margrette Ryland-Daigle.

Description of PCRs

Kaitiakitanga

- 23. Kaitiakitanga involves guardianship, conservation, education and protection measures and practices.
- 24. NHOTA practices kaitiakitanga in respect to the specified area.
- 25. Access to all parts of the specified area is a key requirement of NHOTA's continued practice of kaitiakitanga.

Tending to Fish Nurseries

26. NHOTA preserve, protect and tend to a number of fish nurseries/hatcheries within the specified area.

Grounds for PCR

- 27. The PCRs described above have;
 - a. Been exercised since 1840;
 - b. Continue to be exercised by members of Te Popoto in/at the specified area in accordance with tikanga; and
 - c. Are not extinguished as a matter of law.
