- [1] By joint memorandum dated 31 January 2025 counsel in the above matters have indicated that although the Court has indicated that fixtures be allocated for their hearing, dates have not been able to be assigned. Counsel advise that Te Arawhiti have informed them, by letter of 18 December 2024, that until such date as a hearing has been scheduled, Te Arawhiti is not prepared to consider the funding application.
- [2] Counsel therefore seek confirmed fixture dates.
- [3] The Court is now able to allocate confirmed fixtures in the following matters:

- (a) Ngāti Tara (CIV-2017-404-578) 12 weeks commencing 12 April 2027 in Whangārei.
