
## MACA Mokau ki Runga Hearing Overview

#### 1. Hearing Area

Mokau ki Runga have two separate applications: CIV-2017-485-216 covering a northern area from Tirua Point to the Mokau river, and CIV-2017-485-209 covering a southern area from the Mokau river to the Wai Pingao Stream. In 2023, they proposed a hearing for the northern area. Ngāti Tama sought a southern boundary that matched their northern boundary (shown as a green line below) so that they would not have to join the northern hearing. This amended area was confirmed, and a 3-week hearing was allocated by Churchman J in December 2023.<sup>1</sup>

The Mokau ki Runga North hearing area is shown in purple above. The dark blue portion has been carved off CIV-2017-485-216 and will be determined as part of the CIV-2017-485-209 application shown in teal.
