- [1] Counsel for those applicants who have given notice that they intended to appear at the case management conference scheduled for New Plymouth on 24 June 2019 and counsel for the Crown have filed memoranda agreeing as to the directions to be made. Accordingly, the following directions are made by consent:
 - (a) CIV-2017-485-209: (Ngā Hapū o Mōkau Ki Runga) is transferred to the Hamilton Registry and adjourned for 12 months.
 - (b) CIV-2017-485-216: (Ngā Hapū O Mōkau Ki Runga) is transferred to the Hamilton Registry and adjourned for 12 months.
 - (c) CIV-2017-485-210: (Araukuuku Hapū) is adjourned for 12 months.

- (d) CIV-2017-485-213: (Ngāti Tū Hapū) is adjourned for 12 months.
- (e) CIV-2017-485-282: (Ngāti Ruanui) is adjourned for 12 months.
- (f) CIV-2017-485-309: (Ngāti Mutunga o Wharekauri) is adjourned for 12 months.
- [2] A number of matters that were scheduled to be called on 24 June 2019 have already been disposed of by adjournment with the appearance of counsel on 24 June being excused:
 - (a) CIV-2017-485-243: (Te Korowai o Ngaruahine Trust).
 - (b) CIV-2017-485-212: (Taranaki Iwi).
 - (c) CIV-2017-485-215: (Ngāti Mutunga).
 - (d) CIV-2017-485-310: (Te Ātiawa (Taranaki)).
 - (e) CIV-2017-404-534: (Ngāti Tama).
 - (f) CIV-2011-485-803: (Okaha Inuawai Hapū).

- [3] There are three applicants who are self-represented who have not responded to the minute of the Court (No. 2) of 2 May 2019. They have not filed maps of the area to which their claims relate, nor any memoranda detailing the current status of their claims. The Registrar has been unable to contact them to clarify their current position. They are:

If they do wish to continue with the claims, the memorandum should detail what steps they have taken to prepare their claims for hearing, including whether or not they have engaged an historian and how far advanced they are with the preparation of evidence and maps outlining the area to which their claim relates.
- [5] The participation of all counsel who have filed memoranda in relation to the case management conference on 24 June 2019 is excused. If any of the parties who have not filed memoranda and who have not been able to be contacted, turn up at the Court on 24 June 2019, the case management conference will proceed by way of AVL link with the High Court at Wellington.
